Effective 1 August 2017, HSBC Mauritius will accept audit confirmation requests via Confirmation.com. ***We will continue to accept audit confirmation requests sent via fax or post until further notice.***

Some of the reasons this new solution has been implemented to ensure:

- Client data is properly managed and handled by authorised parties
- The bank and audit firms comply with all required regulatory requirements and laws
- The appropriate security and protection of client data
- Information is sent and tracked only between the bank and authenticated audit firms
- To improve general control, management and efficiencies with the large volume of requests

# Getting Started:

## Audit firms are required to register on Confirmation.com:

- a. Open [www.confirmation.com](http://www.confirmation.com) in a web browser
- b. Click sign up and complete the online registration form

## There is a simple 5-step process to send a confirmation request to the bank:

1. Create a Client Profile
2. Add Client Accounts
3. Obtain Client Authorisation
4. Initiate Confirmation
5. Download Completed Request

## Bank Client authorisation process (Step 3):

- When creating a client profile on Confirmation.com, an auditor will need to add the relevant client bank signers to the client profile.
- The auditor will then need to request authorisation from the client via Confirmation.com.
- A system generated email ([systems.administrator@confirmation.com](mailto:systems.administrator@confirmation.com)) with a link to a secure signing webpage will be sent to the audit client bank signers.
- Once the client bank signers sign and approve the electronic request, the auditor will be able to initiate the audit confirmation to the bank.
