# HSBC and Visa Mauritius E-Commerce Campaign Terms and Conditions

## 1. Overview of the Campaign

HSBC Visa cardholders are required to spend a minimum of 50 US dollars equivalent to Rs.2,000 using any of their HSBC Visa Credit Card and get Rs.200 per Visa card. This promotion is available to every 15<sup>th</sup> customer who pays for online cross border/international/overseas shopping worth 50 USD / Rs.2,000 or more with their HSBC Visa credit card and meets the above requirements. The eligible cardholder will get Rs.200 cash back loaded to their respective HSBC Visa Credit Card.

## 2. Disclaimer

- This Campaign is operated by The Hongkong and Shanghai Banking Corporation Limited that issued the HSBC Visa Credit Card to its cardholders and not by Visa.
- The campaign is financed by Visa. Note that Visa is not a card issuer and does not provide credit, debit or any financial services.
- Any issues with respect to the HSBC credit card should be directed to HSBC and not to Visa. The relationship between Visa and HSBC does not create any relationship direct or indirect between the cardholder and Visa. These terms and conditions are different from the agreements between you and HSBC and unless as otherwise specified in these Terms and Conditions, none of the terms of any agreement between you and HSBC has any effect on, or relationship with these Terms and Conditions.

## 3. Duration

- The cash back is only available to every 15<sup>th</sup> customer who use HSBC Visa Card for online cross border e-commerce purchases with a value of no less than 50 USD / Rs 2,000 (the “Qualifying Transaction”) within 26<sup>th</sup> December 2020 and 31<sup>st</sup> January 2021 (the “Duration”) on a first come first serve basis. Any transactions made outside this period will not be eligible. The campaign will end on 31<sup>st</sup>January 2021, or before if the budget is exhausted, whichever comes first.
- Transactions made within the Duration do not qualify for a cash back , if they do not fall amongst the 15<sup>th</sup> customer as per the campaign mechanics.
- Transactions made within the Duration do not qualify for a cash back, if total budgeted number of winners is exhausted. Note that this is on a first come first serve basis.

4. The Campaign is subject to the following Terms and Conditions

- You become eligible to participate in the programme by holding a HSBC Visa Credit Card issued HSBC in Mauritius (excluding Visa Corporate cards and HSBC staff). Your participation rights and consent are tied to your being an HSBC Visa cardholder.
- Qualifying transactions are online for cross border and of 50 USD / Rs 2,000 and above conducted within the duration to the 15<sup>th</sup> customer. This excludes transactions done within Gaming and Gambling merchants category.
- The maximum cashback award per eligible Visa Card is Rs 200.
- The cashback reward shall be paid directly into the account to which the Visa card is linked. The cardholder is not expected to take any action in this regard.
- Cashback will be awarded to cardholder via an original credit transaction originating from HSBC.
- Only the 15<sup>th</sup> qualifying transactions shall receive cashback, on a first come first serve basis
- Visa takes no responsibility for any inaccurate reporting or non-visibility of qualifying transaction either by collections only files or non-accessibility.
- HSBC will review the transactions from the system and automatically pull the details of the 15<sup>th</sup> customers who shopped online with their HSBC Visa credit card. The customers will receive an email notification from the bank when the cash back credited into their account.
- Each customer will only win once - this will be programmed in the system.
- The exchange rate used for the cash back is: 1 US Dollar = 40 Mauritian Rupees
